**Budget Report:** Accountant Choi Choi

For the month of April, Choi reported the revenues and expenses for all funds were on track as usual. For the Fire Department, we received \$3,867 for the reimbursement of the well. For Street we paid an additional \$450 for the cleanup of debris from storms. Cash Balance: General Fund \$68,042, Fire \$22,381, Street, \$206,183, Money Market \$70,813, CD \$18,162 and CDBG/WSPP \$43,404. Total \$424,968.

**4.Streets and Streetlights** Councilman Ho – nothing to report


**5.Parks and Recreation** – Councilman Fitch – nothing to report
