A STATE GRANT AWARDED BY THE MN DEPARTMENT OF HEALTH, OFFICE OF HEALTH EQUITY - COMMUNITY SOLUTIONS INITIATIVE TO PROVIDE SOME OF THESE SUPPORTIVE FAMILY SERVICES AS WELL AS A PILOT HOME/VIRTUAL VISITING PROGRAM FOR PRIMARILY ENROLLED FAMILIES OF MAICC WITH CHILDREN UNDER THE AGE OF 3. THE INCOME GENERATED IN 2022 WAS APPROXIMATELY \$83,476.00.

MAICC ALSO RECEIVED GRANT FUNDING FOR GENERAL OPERATIONS. A TOTAL OF 7 GENERAL OPERATING GRANTS RECEIVED IN 2022. THE INCOME GENERATED IN 2022 WAS APPROXIMATELY \$310,000.00.

IN 2022, A TOTAL OF 24 CHILDREN WERE PROVIDED WITH CARE AND EARLY LEARNING. THIS REPRESENTS NINE (9) NEWLY ENROLLED CHILDREN AND FIFTEEN (15) CHILDREN WHO CONTINUED SERVICE FROM THE PREVIOUS YEAR. THESE CHILDREN REPRESENT TWENTY (20) FAMILIES SERVED AND SUPPORTED.

THE PROGRAM EXPENSES FOR MAICC ARE ALLOCATED IN THE FOLLOWING WAYS:

PERSONNEL (76%) ALLOWS MAICC TO PROVIDE DIRECT SERVICE TO CHILDREN AND PARENTS, BUILDING & SPACE (10%), OPERATING EXPENSES (7%), PROGRAMMING (8%) COMPRISED OF ACTIVITY/PROGRAM COSTS (0.4%), CLASSROOM SUPPLIES (1.2%), FOOD (2.0%) TRANSPORTATION EXPENSES (0.9%) AND PARENT SUPPORTS (0.7%) AND FAMILY STABILIZATION (2.0%).
