BOARD PROPOSE UTILITY RATE CHANGES

The Board of Directors approved the following preliminary changes to the monthly utility rates:

Proposed Monthly Sewer Rates **effective 7-01-20**

Single Family	\$46.21
Multi Family	\$46.21 first RUE plus \$20.63 each additional RUE or unit
Commercial	\$46.21 first RUE plus \$20.63 each additional RUE

Water and electric rates are proposed to increase annually by **3%**, and sewer rates by **10%** for the next five years. All new rates take effect July 1st, 2020, with the exception of the residential electric rates, which take effect on January 1st, 2020. The Board will continue discussing utility rates at future meetings and rates may be adjusted further before their proposed effective date. The board will discuss preliminary adjustments to utility connection fees and adjustments to Ordinance 71: Administrative Rate Schedule for Electrical Usage (first reading) at the November 21, 2019 board meeting. The public is encouraged to attend and provide comments.

On Wednesday November 6th Shelter Cove community members, RID directors & staff, Humboldt County Supervisor Estelle Fennell, representatives from State Water Resources Control Board (SWRCB), LACO & Associates and GRS Construction gathered at Beach and Shelter Cove Roads to rededicate Kennedy (million-gallon) Tank and celebrate the completion of RID's water tank replacement project. Our community has six new metal water tanks in service thanks to a five-million-dollar grant from California's Prop 1 initiative.

I would like to take the opportunity to share a special thanks for the work performed by current and former RID employees Phillip Young, Sue Sack, Brian Speelman, Bud Lair, Michael Briggs and Frank Wilson; Scott Kelly and the staff of LACO, Chris Hake of GRS, Deisy Rios of SWRCB and the RID Board of Directors who made this water tank replacement project possible. Tis the season to give thanks and I have one more to give. I have a very special thanks to SCOPA (Shelter Cove Property Owners Association) for providing funding for the purchase of three intersection mirrors along Shelter Cove Road. These mirrors were installed by RID staff and will help provide better visibility at both upper & lower Toth and Willow Glen's intersection with Shelter Cove Road. Thanks SCOPA!
