Cancellation/Refund Policy

Is it possible to get a refund?

The only circumstance in which you will receive a refund is if we do not begin work on your I.S. program within 60 days from the date of purchase.

What if I change my mind and want a different package?

If your order is in a queue or being processed, your order has been placed, and therefore we cannot refund you.
