

**TOWN BRUSH SITE**

Ordinance No. 11022022

**Section I - Purpose.**

The purpose of this ordinance is to regulate the disposal of materials in the Town of Chicog's Brush Site located on Christiansen Road.

**Section II - Authority**

The Town Board of the Town of Chicog adopts this ordinance under WI. Stats. 66.22(1)

**Section III – Adoption of Ordinance**

This ordinance, adopted by a majority of the Town Board on a roll call vote with a quorum present and proper notice having been given provides for the correct use of the Town Brush.

**Section IV- Who may use the Brush Site**

The Town of Chicog Brush Site is available for the property owners of the Town of Chicog.

**Section V-Excepted Materials**

Materials suitable and excepted shall be:

Brush, branches, logs, stumps, and yard debris consisting of grass clippings, pine needles, leaf debris and or plant materials only.

**Section VI – Non-Excepted Materials**

Materials that are not excepted or suitable are as follows but not limited to:

a. Construction Materials – Meaning any and all materials related to construction. to include:

1. Roofing materials, wood or landscape timbers, lumber of any type/kind, home siding, trim work, windows, doors or decking.
2. Metal materials related to construction.
3. Concrete in forms of excess run off, block(s) of all types and dimensions, chimney flues, landscape pavers, ceramic and stone tiles.

b. House-hold appliances

c. Car parts

d. Agricultural equipment

e. Siding of any kind metal or vinyl

f. Yard Lamps

g. Satellite & Microwave Dishes

h. Dimensional Steel

i. Sporting equipment

- j. Glass products of any kind
- k. Paint, oils, hazardous chemicals

These materials listed above are to be disposed of at a proper facility.

**Section VII – Penalties and Fees**

a. Any person, partnership, corporation or other legal entity that fails to comply with the provisions of this ordinance shall, upon conviction, pay a forfeiture of \$500.00 and required to remove all such debris from the site plus the applicable surcharges, assessments and costs for each violation. Each day a violation exists or continues constitutes a separate offense under this ordinance.

b. Penalties set forth in this section shall be in addition to all other remedies of injunction, abatement, or costs whether existing under this article or otherwise.


**Section VIII - - Effective Date**


This ordinance shall be effective as of the date of publication in the town’s official newspaper or posting in accordance with Wis. Stats. 60.80


