OPENING: Gary opened the meeting at 7:30 p.m. Fred made the motion to approve the minutes for October 13th & 30th, 2014. Brent seconded the motion. All approved. Gary signed the minutes. The selectmen signed the orders for October. The Selectmen received the budget report to date to review. **CITIZENS CONCERNS** David Morrison thanked the select board for approving the High Ridge Rd project and thanked Lisle for the work done. He wondered what obligation the town would have if for example, the town road was higher than an access way into a field. Lisle explained that naturally the town road should be higher than an access way so that water drains away from the road rather than onto the road from an access point.

Gary asked that Heather get information at her next NEKWMD meeting about if the NEKWMD will be helping in providing a bigger facility if needed or what options the town has.

HEALTH INSURANCE RENEWALS Health insurance renewals will remain with Blue Cross Blue Shield. **STATE REIMB FOR LEGAL FEES** The town received \$7,040.64 for reimbursement of legal fees for TransCanda litigation.

RESIGNATION FROM DRB Charles McMahon has resigned from the DRB due to personal reasons. The selectmen accepted his resignation and wish him well.
