 - Insurance Blake is waiting until we get final numbers for insurance. We will then purchase the insurance with final (or as close as we can) numbers that way we can renew the same time each year. That will be the end of February. This will be tween \$3000-\$4000.

7. Unfinished Business

• Discuss Route 13 league—Blake attended the meeting in Herrin and it isn't at all what we originally thought. It is more of a rec league program with the surrounding towns involved. These towns are using this league as their rec league program because they don't have rec leagues in their own towns. They don't want our All-star teams playing. 14U boys will be the only ones to play in this league. The league is giving us the option (and would like) to have a board member from our town. We talked about this at the meeting and all were in agreement that it isn't worth out time to have a board member. Perhaps we could have a representative/contact person, but not a board member. Blake will contact Garrett to see if he would be interested since the 14U boys will be the only ones in the league.

- 2020 Baseball/Softball Rec League

We will change section F under Playing Rules to define overthrow(n) to an overthrown ball/wild pitch, the runner will be allowed to advance one base.
 - O Discuss Bat Rules We are not going to check every bat and parents can purchase any bat they want to buy for their child.
- Board Member Background checks this will be costly this year as we will background check anyone helping with any HYA program. We will check coaches, assistant coaches, board members and others that work closely with the children (i.e. TA and Debbie and Lonnie). The process is simple.
