I fully understand this Consumer Credit Report Consent is not an approval or contract or a promise for an approval or contract for a boat slip lease at the Stockton Downtown Marina.

I fully understand that the \$50.00 credit report fee is non-refundable, and required as part of the boat slip lease application process, regardless of whether or not the application is approved.
