The Infrastructure Investment and Jobs Act has been signed into law!

What does that mean for the country? — The bill provides funds for much-needed improvements to America's transportation and utility infrastructure and includes a historic \$65 billion investment in our country's broadband networks and good jobs.

What does that mean for our members? — Rules that protect good telecom jobs by prioritizing the distribution of broadband funding to projects from responsible employers with high labor standards. It is critical that broadband is built out by skilled union members who know how to do the job correctly and safely and this is the very first time that

This law will provide good work for CWA members, and strengthen our union. Everyone, no matter where they live or what they earn, deserves to have access to affordable, high-speed and reliable internet services and CWA members are ready to build those broadband networks out right.

The Senate Must Pass Build Back Better Act

Now that the Build Back Better Act passed the House of Representatives, we are one step closer to providing working families with the essential support they need as they continue to struggle with the effects of the pandemic.

The bill will ease the burdens of the pandemic and will help working families and retirees build a better future by expanding access to preschool and child care, extending the Child Tax Credit, instituting paid family and medical leave, allowing Medicare to negotiate prescription drug prices, and much more.

With the Build Back Better Act, we have a chance to pass huge labor reforms, including these pieces of the PRO Act:

- · Real financial penalties for employers who retaliate against workers organizing a union
- · Personal liability for executives who knowingly break labor law
