

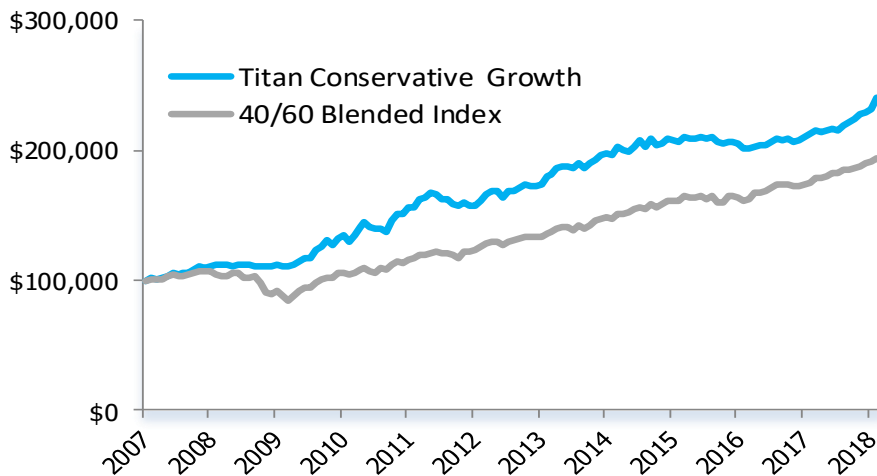
## Investment Philosophy

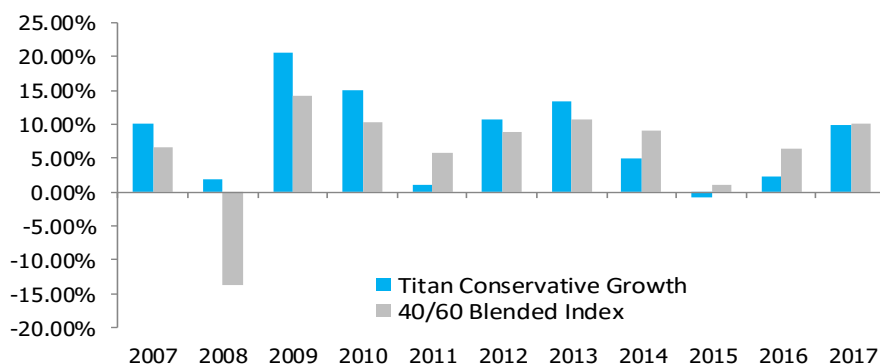
## Strategy Objective

The Titan Conservative Growth strategy is designed to generate growth and income. It seeks to deliver higher returns with less downside volatility than the 40/60 balanced index. The strategy includes multiple models and can invest in stocks, commodities, REITs, MLPS, bonds, currencies or cash. There are no fixed allocations to any of the asset classes mentioned above. The strategy has the ability to allocate up to 65% in stocks as well as 100% in cash.
