# TOWN OF CHICOG Town Board Meeting March 18, 2020

- 1. The Town Board Meeting was called to order at 7:00 pm at the Town Hall.
- 2. Pledge of allegiance was recited.

- 4. Treasurer's Report was given as follows all balances as of February 28, 2020:

#### 5. Chairman's Report:

- a. "Coronavirus" Most all public functions have been cancelled. Avoid all possible contacts where you can this is a serious situation. You are attending this meeting tonight at your own risk.
- b. The annual road restrictions have been put into action. With these early restrictions we would hope to see early improving conditions so that you may continue your normal operations. If a variance is required contact a board member as to current conditions and approvals. A signed document is required and preset in the vehicle.
- c. Washburn County Highway Department is limiting and monitoring on their grounds the amount of salt and sand that you may take for driveways and sidewalks.
- d. Construction materials will no longer be acceptable to dispose at the town's dump due to nails, screws and sharp foreign objects. Tires are too expensive to replace or repair on the town's equipment.
- e. Hopkins Sand & Gravel will be crushing in the tubs pit this year, gravel will be crushed at a rate of \$5.35 per yard
- f. you may have noticed the brushing and cutting operations on some of the town's roads this spring. We have had a couple of complaints already. Test assured all trees will be treated equally. We are making a great effort to due diligent maintenance to our roads and respective right of ways. (56.69 miles of local roads).
- g. We would like a highway department tab on the Town's website for notifications of upcoming constructions, Highway hazards and information of highway regulations and State Statutes.
- h. Highway projects on our radar for this summer are Christensen Road and Bramer Road. We are also looking at McClain Lake Road, right of way issues.
