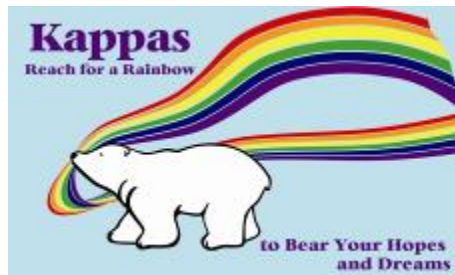

Job well done! It is obvious the above photo was taken after the completion of this committee's work at National Headquarters in Tulsa during the first week in March, as all are sporting smiles of accomplishment.

A major responsibility of the Business Committee is to review, adjust, and complete the coming fiscal year's budget, as proposed and presented by Executive Director Pat Fluegel, to present to the Executive Committee for their approval for presentation to the membership at the National Convention. In doing so, the committee considers the needs for maintaining Headquarters, reviews office supply and equipment needs, and then recommends any purchases, changes in services/practices, and/or service providers to the Executive Committee, along with any additional concerns of staff, groups, and individual members. Employee salary/benefits and policies are also reviewed, with recommended changes presented to the Executive Committee. A great deal of time and deliberation goes into this entire process, and the committee attempts to evaluate the needs of the organization to operate within its means.

A Business subcommittee conducted an in-house audit of the financial records and office operations. The committee did a test sampling of transactions and balances, along with completing an overview of records, internal controls, and office procedures. Executive Director Pat Fluegel and Advisor Linda Smith were available to answer questions, as needed. An audit report was completed, and notes and recommendations were reviewed with Executive Director Pat Fluegel.

## 2010-11 SCHOLARSHIPS AVAILABLE

Over \$12,000 in national scholarships were awarded in the last two years. The total number of scholarships is based on money available and number of qualified applicants.
