

### EGNER FAMILY HISTORY

1727 - 1992

### Introduction

The story of the first five generations in this history of the Egner family is based mostly on information in letters from Jennie (Egner) Nelson to Lois (Egner) Brask which were written in 1964. The letters did not include much information for dates of births, marriages or deaths, nor much information about specific geographical locations for such events. However, as specific geographical locations for such events. However, as discussed in Table 1, the Egners originally settled in or near what became Bucks or Lehigh Counties. Jenny Nelson's letters what became Bucks or Lehigh Counties. Jenny Nelson's letters did indicate that the later generations lived in that area, and Sylvester Egner (Table 7) lived in or near Limeport as late as the 1940's.

Information for the later generations is more complete. It was provided by Adele (Egner) Ireland, Lois (Egner) Brask, and Diane (Egner) Pelosi.

The information is set forth in charts and a series of tables. These tables include male Egners in the direct line from John Mathers Eichner (Generation I for the purposes of this history), through Russell Forrest Egner Jr. (Generation VII), and John Egner (Generation VIII). There are also tables which present maternal side history for some generations, as well as special sub-tables to present information about female family members and their marriages.

Roman numerals are used in the charts and tables for numbering generations. Arabic numbering is used for the tables, but these have no sequential significance. Cross-references in the tables, asterisks in the tables at names in the direct Egner tables, and the charts, should permit the reader to follow the history.

More detailed Egner family information could likely be found. Apparently much of it exists in a book mentioned by Jennie Nelson, which was in the possession of "Mrs. Decks or Forney" in 1964. Jennie also mentioned the headstones at the old and new cemetaries at Blue Church, located between Limeport and Coopersburg, Pennsylvania. Apparently some of the inscriptions are in "High German".

The family name was originally Eichner, later changed to Egener, and finally changed to Egner. Since no dates concerning the changes were available to this writer, this history arbitrarily uses Eichner for Generation I, Egener for Generation II, and Egner thereafter.

### TABLE I.

JOHN MATHERS EICHNER's family emigrated to America from the Palatinate in Germany in 1727, according to information provided by Jennie Egner Nelson. In the 11th century, the area was ruled by a Count Palatine (a Palatine being a person with royal connections). Eventually, the area became a part of Bavaria, was incorporated into West Germany after World War II, and as of 1992, is part of the unified German Republic.

Based on birthdates in later generations, it appears that John Mathers was born in the 1730's in the Pennsylvania Colony.

John married Barbara Knappenberger. Children of the marriage:

Mathias-Married a member of the Aughster family, two children.

Peter-Married Susanna Stout, two children.

\*Henry, see Table 2. Married Catherine Schneider.

John, married Catherine Boger, six children.

Other children included Daniel, Solomen, Christian, Catherine, Eva, Elizabeth.

In the mid 1800's, Egners were living in what had become Lehigh and Bucks Counties in the State of Pennsylvania. This is likely the area in which John Mathers Eichner's family originally settled, as did numerous other Germans, as a result of William Penn's liberal policies. (In just the short period between 1683 and 1685, more than 3000 Quakers and Palatinate Germans settled in the Pennsylvania Colony).

II. HENRY EGENER, son of John Mathers Eichner (See Table 1), was born in the Pennsylvania Colony, probably in the 1770's. He married Catherine Schneider. Children of the marriage:

\*Thomas, see Table 3. Married Hannah Weider.

Other children included Sarah, Catherine, Esther, Elizabeth, and Judith.

III. THOMAS EGNER, son of Henry Egener (see Table 2), was born in Bucks or Lehigh County, Pennsylvania in about 1800. He married Hannah Weider. Children of the marriage:

Charles B., married Amanda Fatzinger, four children.

Daniel, married Lydia Mohr, two children.

Ambrose, married Mary Young, two children.

Mary, married Soloman Weaver.

IV. ABRAHAM SASSAMAN was born on December 28, 1813, and died on July 2, 1896. He married a Moyer who was born on April 27, 1810, and who died shortly after Abraham on August 9, 1896. Children of the marriage:

Anna, born November 30, 1838, died April 26, 1858. John, born October 5, 1840.

Matilda, born August 8, 1842, died October 28, 1866.

XElmira , born August 18, 1844. Elmira married Charles Bitting, see Table 6.

Sarah, born August 15, 1846; died November 11, 1866.

Abraham, born April 13, 1848.

Susan, born December 5, 1849; died November 9, 1866

Daniel, born October 23, 1851; died November 8, 1866.

All of the children were born in Springfield Township, Bucks County, Pennsylvania, except Anna, who was born in Harford Township, Bucks County.

The Sassamans lost four of their eight children to typhoid fever in the two week period from October 28 to November 11, 1866. Their first born, Anna, died in 1858 of "Hasty Consumption, a very short illness."

Fortunately for Egners born after 1870, the Sassaman's fourth child, Elimina, survived the typhoid epidemic, married Charles Bitting, and was the mother of Alice Isabell, who married Sylvester Egner.

Jennie Nelson recalled her great-grandparents, the Sassamans, in her letters. She mentions that both were pipe smokers. She also told of walking from South Bethlehem to Seidersville to get cabbage from Abraham, who gave her twenty-five cents worth. This was so much cabbage that Jennie had to take the trolley home, which cost three cents,

IV. JOHN ADAM EGNER, son of Thomas Egner (See Table 3), was born in Bucks or Lehigh County in about 1840. He married Hannah Wieder. Children oof the marriage:

\*Sylvester, see Table 7. Married Alice Isabell Bitting. Malinda, married a Schuler.

There were seven other children.

IV. CHARLES BITTING was the son of Francis Bitting and a daughter of the Nase family. He married Elmira Sassaman, daughter of Abraham Sassaman (Table 4). Children of the marriage:

Alice Isabell, who married Sylvester Egner. (Table 7)

Ida, who married Charles Harwick.(4 children)

Dora, who married Henry Ritter.(3 children)

Annie, who married Howard Cressman.(3 children)

Sally, who married Titus Erney.

Photographs orf Charles Bitting with his grand-daughters, Alice and Adele Egner, were taken after he had lost his left arm at age 80in an accident, which is related in one of Jennie Nelson's letters. It seems that Charles was driving a horse drawn wagon, delivering a load of corn. When he was near a railroad crossing at Coopersburg, Pennsylvania, the horse shied as a train approached, throwing Cfharles from the wagon and into the path of the train. His arm was injured and amputated. He lived to age 86.

V. SYLVESTER EGNER, son of John Adam Egner(Table 5), was born in about 1870, apparently in Bucks or Lehigh County, Pennsylvania. He died in the 1940's in or near Limeport, Pennsylvania, where he had lived for most, if not all of his life. Sylvester married Alice Isabell Bitting(Table 6), and they had four children, all born in Limeport:

Jenny, born June 3, 1898. Died in Allentown, Pennsylvania, in the 1970's. Jenny was married to Lloyd Nelson.

\*Russell Forrest, born June 1, 1895. See Table 9.

Lois Egner Brask recalls her Grandfather Sylvester visiting the Russell Forrest Egner family in Minneapolis in the 1940's. Sylvester took the children fishing, and during that outing a fish hook became lodged in Lois' back. Grandfather successfully removed the hook.

V.CHARLES BOARD, married Elizabeth Drain. They had one daughter, Eileen Laura, who was born in Sheboygan, Wisconsin on March 19, 1899, or 1900. Eileen married Russell Forrest Egner. (see Table 9)

Charles Board was a retail grocer. His store and the family residence was located at 812 North 5th Street in Sheboygan. Charles was also an accomplished violinist.

Elizabeth Board was a school teacher, and probably also worked in the grocery store. During her later years she lived in the St. Clements home, since Charles preceded her in death. She was very active there, and enjoyed being visited, as well as visiting others. Elizabeth, called "Gonnie", by her visiting others. Elizabeth, called "Gonnie", by her Grandchildren (and most other relatives), died in the 1950's. She is buried in St. Clement's cemetary in Sheboygan, as is Charles.

"Auntie" Sanville was a sister of Elizabeth who lived with the Board's and worked in Charles' grocery store. She had two children, Charlotte and William. Charlotte married Roy Zepherin. They frequently visited Elizabeth at St. Clement's from their home in West Allis, Wisconsin.
