- 2. Review of 2017-2018 ASMC Chapter Calendar. The following change was made:
  - a. Corporate was removed as host from the luncheon rotation due to being the lead for PDI and Annual Golf Tournament.

    - i. \$15k revenue from Golf Tournament

    - iii. \$1.2k collected for the Chapter being recognized by National for 5 Star Competition (\$1k) and Membership Growth (\$200)
  - c. Cash balance is projected to remain above \$300k
