



Dear Friends and Family,

Greetings in the name of our Blessed Lord, Jesus Christ! The Lord has been blessing us with more churches taking us on for support since our last letter. We have had three more churches take us on for support. This now brings our support percentage to 66%!

Since our last letter, we have had some wonderful blessings and also some trials. As we get closer to leaving, I am not surprised that we have some new trials. The blessings are that we sold our home and that the Lord also provided for us to upgrade to a newer van. Thank you to those who have helped us fund the purchase, and for those who have been praying for our home and our vehicle.

It is amazing how the Lord works. I fully believe that I was summoned for jury duty solely to enable us to be home for our Camp Meeting in Gaylord. It was during that week and the weekend afterward that a gentleman made an offer for our home. It was close to what we were asking, and we accepted. We were able to get it successfully transferred, and the money which exceeded the remainder of the loan and our tithe, we put into a savings account for our startup fund for Ireland. We are planning on putting our monthly support above deputation expenses into this account. The funds will go toward securing housing, plane tickets, a vehicle in Ireland, etc. Another neat thing is that I was summoned to serve four weeks of jury duty and never served a day! I believe God used it to make sure we were home expressly to answer our prayers for our home to sell and a vehicle. All that we have remaining to get to Ireland is our support!

The trial that we also entered began the week right after Camp Meeting. Jennifer began experiencing severe pain in her abdomen after she ate. It often had her on her knees and was severe enough that I took her to the E.R. They thought it was her gall bladder, but after some testing, the doctors said it was working fine. They said that it may be bacteria that had burned the stomach lining, and every time she eats something rough or hard to digest, it rubs against the burn and caused the pain. Through trial and error we have discovered what she can eat. She is doing much better and can now eat more of what she used to. We were told that it usually takes 90 days for an organ to heal.

Thank you for your continued prayer for her health, faithful prayer during our deputation, and financial support. We are excited that each day draws us closer to Ireland.
