Approval of minutes: The Selectmen signed the minutes and orders. Gary made the motion to accept the February 11th minutes. Fred seconded the motion. All approved. Fred made the motion to accept the February 26th minutes. Gary seconded the motion. All approved.

Budget Report: Steve presented the budget report to date.

Citizens' Concerns: David Morrison shared his encouragement to the Selectboard in preparing the survey for 2020 Town Meeting time.

Fred made the motion to have Gary work with Linda Mitchell in preparing and mailing to each residency in Waterford the survey regarding the 2020 Town Meeting time. Bill seconded the motion. All approved. **Truck Update:** Nothing currently. Removed from agenda.

Remick/Woodland Road Intersection: The gentleman whose property meets Woodland Road and Remick Road would like stop signs installed at that intersection. Stops signs are not encouraged at this intersection. Lisle informed the Selectboard that the intersection has poor visibility and would like to instead provide slope work which will increase the visibility. Lisle contacted Mike Hemond (whose property abuts both roads on the other side) and he is okay with the proposed work. The Selectboard will also discuss with Shauna Clifford (state engineer) at their Annual Highway Meeting.

Other: Lisle informed the Selectboard of an electrical truck fire that occurred with truck 4. The Highway Crew were all safe and acted quickly in the emergency. The repair costs are just under \$20,000 which are covered by the town insurance company.

Steve asked for approval to give the fence code to Fred's Plumbing & Heating. Selectboard approved.

Recycling Committee Update: Jessy will touch base with committee members to determine dates available to meet with the Selectboard. Removed until there is an update from the committee.

Unified Development Bylaw Update: Nothing currently. Removed from agenda.

USPS Lease Renewal: Dave Morrison encourages the renewal. Gary made the motion to renew the USPS lease renewal for 5 years. Fred seconded the motion. All approved.
